# Background

Parkland School Division is proud of the work accomplished on the Board priorities during the 2014-2015 school year. Progress toward realizing the outcomes stated in the 2014-2017 Three-Year Education Plan has been significant and is noteworthy, especially in the areas of early learning, wellness and building inclusive environments.

The chart below highlights a broad overview of the Division's accomplishments this year. It also provides some initial thoughts for the next steps required to maintain the current momentum around the seven strategic goals targeted to achieve our Division Priorities: Engage our Students, Engage our Staff, Engage our Community, and Stewardship of our Resources. While student success and well-being has been the ultimate goal for the work undertaken, it has been planned and carried out by promoting innovation and collaboration as foundational underpinnings of how we work.

At Parkland School Division, we know that student success is closely linked to the student well-being and the development of social-emotional assets that build resiliency. That's why we are deeply committed to the development of the whole child at all levels of education and have established a greater vision for our priority areas.

Renamed the Wellness Initiative in 2015, the Initiative aims to build health and wellness in schools and communities through capacity building, programs and partnerships. The program focuses on developing strategies, partnerships, and resources to support a more equitable foundation for wellness and resiliency in our school communities. The project was formalized by the Parkland School Division's development of:

- An Ultimate Goal of outlining the interconnectedness of student achievement and well-being
- A full-time youth resiliency coordinator position that works on behalf of the division to support school communities in using comprehensive school health pedagogy to strengthen the well-being of students, families, and communities.
- Designation of site-based health champions who receive additional professional development support on comprehensive school health planning and are supported by their administration
- Community and provincial resource and partnership development that will accelerate our impact on children's health issues

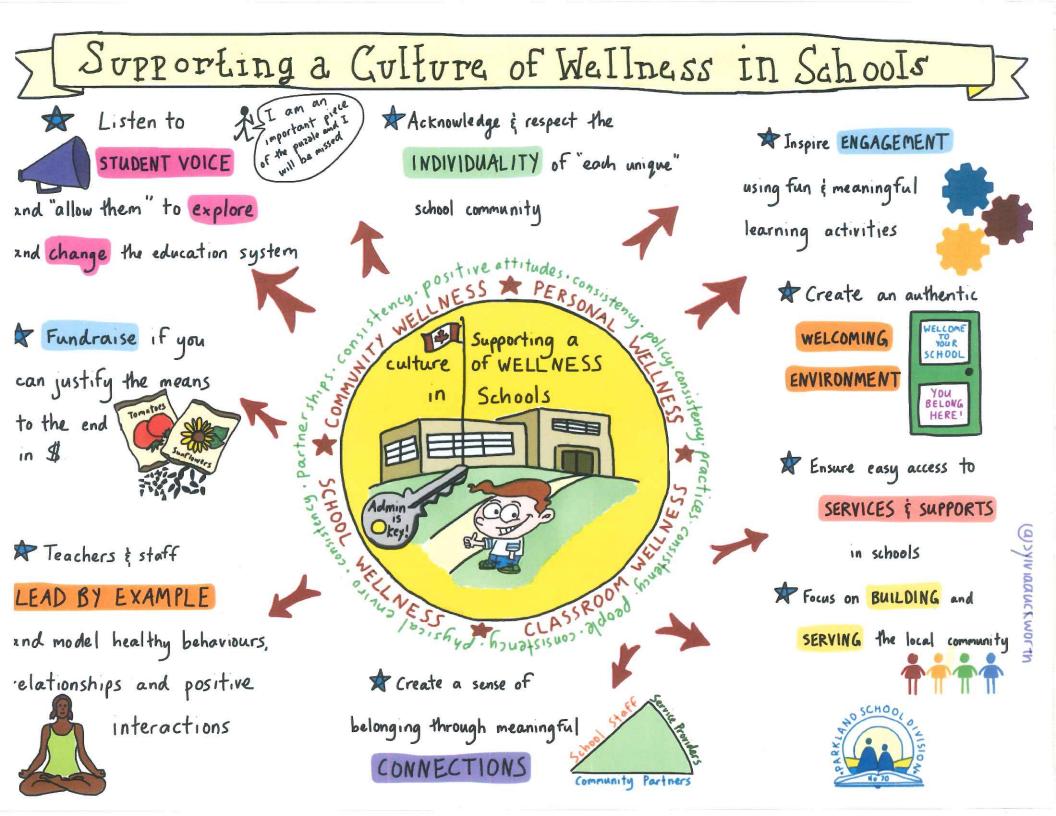

# Strategies to Initiate School and Community Partnerships

Creating a healthy school community requires expertise and resources from both schools and community organizations, however, navigating these partnerships can be challenging. Where is the best place to start? How are trusting relationships built?

There are so many champions throughout Alberta working together on exciting projects, including greenhouses, breakfast clubs, run clubs, after school programs and more, and we wanted to share one of these stories with you.

Meet Jennifer Telfer, Wellness Program Coordinator at the TransAlta Tri-Leisure Centre in Spruce Grove, Alberta. She believes school and community partnerships begin by meeting that one key person. For her, that person was Felicia Ochs, Youth Resiliency Coordinator for Parkland School Division. She admits that just meeting Felicia wasn't the answer to creating the partnership, but it was a great starting point.

Their initial meeting resulted in a plethora of ideas, but their higher-ups quickly told them that it was a futile exercise and that the partnership wouldn't work. Jennifer and Felicia continued to discuss ideas and started with a few small projects to test the waters.

Fast-forward to today and Jennifer and Felicia can take credit for a group called Physical Literacy and You (PLAY) Parkland, which is a community group advancing physical literacy in Parkland County. Some exciting things have come from this group including after school programming, school packages, a program on wheels, resource sharing and whatever Jennifer and Felicia dream up next!

Despite their success, challenges are still present. These programs and services cost money and funding is always a discussion point. Different organizations work on different timelines and within different constraints. Staying on the same page and working together on common objectives is an ongoing task to ensure this partnership and its projects can be maintained. Jennifer's advice on getting these partnerships started is to begin with the "why." Your values and mission will drive practices and decision-making. Make sure your desired outcomes align with your partner's.

Next, examine the "who." Identify the people who should be involved to make your desired outcomes happen. Make time in your schedule to network—this is where you find the right people. Do your homework to find out about past experiences and projects to learn from mistakes and build on successes.

Lastly, Jennifer says it helped her to be passionate, persistent and positive. Great things can happen from an optimistic conversation over a cup of coffee.

# REPORTING PERIOD: September 2014 - May 2015

Within Parkland School Division, staff and students use the power of technology in a purposeful and meaningful way to deepen understanding and demonstrate learning. The 2014 - 2015 school year brought many challenges and changes in an effort to improve Educational and Information Technology service delivery to staff and students.

This school year Parkland School Division concentrated on creating a formal strategic technology plan for implementing the Alberta Learning and Technology Policy Framework (LTPF). The work to achieve the goals laid out in this plan is underway and will continue into 2018.

# Goal 1: Provide a robust digital infrastructure that meets Divisional needs for the next three to five years.

Achievements:

- Parkland School Division has reliable infrastructure that supports safe, secure, efficient, interoperable and sustainable networks. The Network Infrastructure Refresh Project was approved and began this school year. 17 of 24 sites have been completed.
- Wireless networks will sustain high speed and reliable current and future need for 3 to 5 years for portable digital device connectivity, both school owned and student owned. Bandwidth has been increased to 100 MBps at all sites where the wireless network has been upgraded. High schools will be moved to 500 MBps when our service provider is able to upgrade equipment.
- Server infrastructure meets the needs for education, business, and technology services. 8 school site servers were replaced this school year.
- Systems Software review has been completed and many upgrades are completed or in progress.
  - PSD has moved to a Microsoft product to manage all the PC computers in the Division which is part of the Provincial Licensing Agreement (PML). This move saved PSD \$68,000/annually. (system management and antivirus)
  - Help Desk tickets/requests are now managed by another Microsoft product also included in the PML. This saved PSD \$8,000/annually in licensing fees.
  - Migration of PSD staff to one email, one calendar and contacts system in Google.
  - All PSD staff can access files in Google as well as their J:/drive via Remote Desktop allowing for great accessibility to information and data.
  - PSD has transitioned away from traditional Blackberry phones which required Blackberry Servers, saving PSD \$6000 / annually on software maintenance.
  - Meraki Systems Manager cloud service, which is a free product, allows IT and school sites to manage Apps wirelessly on school owned iPads.

# Goal 2: Develop an implementation plan for the 2013 LTPF in collaboration with Learning Services and school leadership teams.

Achievements:

- Students, teachers and PSD staff have support and <u>equitable access</u> to digital learning environments, appropriate digital devices and peripherals to maximize learning with technology.
  - BYOD opportunities are being offered at: MCHS, SGCHS, SPC, Muir Lake, Greystone, Graminia, and Blueberry. Schools that are planning for the 2015-16 school year are: Broxton Park, Meridian Heights, High Park, and Woodhaven.
  - Schools continue to evergreen and purchase school-owned devices. To note, Chromebooks and iPads are the most purchased product (6:1) versus laptops/desktops.
- Technology is used to support student-centered, personalized, authentic learning for all students.
  - Technology, online learning and digital media are accessed by students throughout the school day depending upon the school site and the learning activity.
  - Public classroom and student blogs showcase learning, share discussions, engage networking with other classrooms, students, parents and community members.
  - Continued work is occurring on how to plan for and utilize universal, targeted and specialized technology and learning supports to remove barriers for students
  - Current applications being offered and accessed by all staff and students within the school division are the Destiny Library System, Discovery Education Canada, Edublogs, Google Apps for Education (GAFE), LearnAlberta, Read&Write Gold and 2Learn.
- Schools and PSD departments have clarity and coherence in practices and procedures to manage, renew, and use technology in learning, communications and business processes.
  - A three year technology plan has been developed with stakeholders for the 2015-18 school year.
- Teachers, administrators and other PSD professionals use technology and digital resources innovatively and effectively for learning, teaching, leadership and administration to align with the Learning and Technology Policy Framework
  - Policy Direction 2 Research and Innovation
    - Digital assessment and supplementation licensed applications being piloted at some schools are Accelerated Reader, IXL Math, Mathletics, RAZ kids, and Solaro.
    - Google Apps for Education (GAFE) is a cloud-based collaborative suite of applications available for staff and students to create, learn, share, publish that integrates with any device, system or network.

# • Policy Direction 3 – Professional Learning

- Continued professional learning for staff is needed to support inclusive learning environments that help students become more confident and independent learners.
- Meeting regularly with Tech Focus Groups made up of administrators, staff and students allows the Division to hear the successes and challenges in operationalizing the LTPF. This will provide appropriate direction in future learning opportunities.
- IT Delivered Training for Supporting the School's Digital Environment The intent of this session is to provide individuals in a school tech support role with some formalized training, and the opportunity to collaborate with other school sites.

# • Policy Direction 4 – Leadership

- Revision of a Administrative Procedures and updating the Social Media Guidelines will be needed to accommodate the use of online applications (like GAFE).
- Build a greater understanding of the LTPF and share leadership successes within PSD through a Research Community of Practice grant with Alberta Education.
- Sharing PSD stories, information and messaging is important. Our schools and Division Communications department share these through the public website, weekly employee newsletter, school websites and Social Media channels such as Twitter, Facebook and YouTube.

# Goal 3: Provide an effective user support structure to enhance technology use in the division.

Achievements:

- Digitally confident teachers, administrators and other staff
  - are well prepared to use technology and digital resources innovatively for learning, teaching, leadership and administration
  - use technology to design personalized, authentic and student-centered learning opportunities to meet the diverse needs and interests of all students
  - engage in professional growth opportunities that are broadened and diversified through technology, social media and communities of practice.
- Teachers are aware of and stay current with educational technology research
  - The ONline weekly staff newsletter shares various professional learning opportunities, tech tips and tricks for staff.
  - Synergyse Training system for Google is available to all students and staff.
  - PSD Technology Focus Group which is made up of an administrator and a staff member per site has met four times this year to share successes, learn about innovative practices and technologies that support learning.
  - The #psd70 Twitter hashtag is well used by PSD teachers to share, learn, network and gain access to other teachers around the world.
  - PSD teaching and IT staff have been able to access provincial educational technology conferences like Google Summit, edcamp and the Convergence Conference.
- Staff have a reliable, effective and timely support to resolve technological issues
  - Reconfiguration of the IT department allows direct and effective service to all sites. Each site within PSD is visited at least once a week by one of five area technicians.
  - Dedicated Help Desk Analysts answering calls for IT and Student Information System related service requests.
  - Resource transfer from Business and Finance to IT in the form of a dedicated Information Systems Analyst for Student Information System administration.
  - Network improvements have occurred more quickly and cost-effectively due to having an onsite Network Administrator
- An effective support and management structure exists for desktop computers, laptop computers and tablet devices.
  - BYOD partnerships with Apple Canada and Best Buy West Edmonton store allow for students, staff and parents to purchase devices to enhance their learning.

# Looking forward to 2015-16.....

- Continue to pursue the achievement of the goals outlined in the LTPF Tech Implementation Plan
- Completion of the Network Infrastructure Refresh Project
- New Student Information System PowerSchool with direct integrations to Business and Finance, Student Records and Transportation.
- Internally provided baseline IT training available for PSD staff
- Digital Citizenship with Bring Your Own Device (BYOD) focus
- Inter Divisional Shared Services for IT infrastructure and knowledge
